Topic: **Xtrackers share migration (wave II)**

Dear Client,

Please note that on SD 10/10, following the internationalisation of the XTRACKERS funds indicated below into the ICSD structure, they will be centralised in ES-MIL with Euroclear Bank as Issuer CSD instead of the previous Clearstream Banking Frankfurt.

Guidelines for the handling of settlement transactions involving migrated securities are provided below.

Only Cross-CSD transactions sent to T2S by the day of migration and which are pending on 07/10 will be deleted from the T2S system without any action by the client.

ES-MIL will not re-enter the cancelled transactions. It will be the client's responsibility to re-enter them as of 10/10 onwards, conforming to the new formats arising from the change in Issuer CSD, to enable the transactions to be settled correctly.
