## Securities issued in Jersey subject to US taxation

Topic: Tax change for securities issued in Jersey

Dear Client,

Euronext Securities Milan announces that certain securities issued in Jersey that were previously subject to the tax law of the country of issue have been brought under the US tax regime.

Accordingly, ES-MIL wishes to point out some important activities to be taken if one of these securities is held in your account:

- if the securities account is not documented in compliance with applicable US law, you will be asked to provide either a W8-BEN-E or a W8-IMY, depending on whether the account is proprietary or third party
- if the securities in question provide for the payment of proceeds, you will be asked to provide form MT550
- in the case of a "reportable" security and where income tax has been paid, it will be included in the 1042S year-end tax declaration.
